## LIMITED WARRANTY

### ***What is Covered***

This Warranty covers all defects in materials and workmanship in any product manufactured by us and purchased from an authorized dealer. This Warranty constitutes the exclusive remedy for all defects of material and workmanship and specifically takes the place of all other express warranties on our products.

### ***What is Not Covered\****

This Warranty does not cover deterioration due to normal wear and tear, and it does not cover perceived defects due to the natural characteristics of wood which may cause some variation in the finish or appearance of the product. It also does not cover repairs or replacements made necessary by negligent use, accidental damage, water-induced damages, or the failure to follow the installation, assembly, adjustment, use or maintenance procedures and instructions contained in the Owner's Manual.

### ***Who is Covered***

This Warranty covers only the original consumer purchaser.

### ***How Long***

This warranty is for a period of one (1) year from the date of purchase.

### ***What We Will and Will Not Do***

We will repair or replace, at our option, any defective product covered by this Warranty. We will not pay shipping or transportation charges nor removal and installation costs.

### ***How Do You Get Service***

You must contact and file a warranty claim with the dealer or distributor from whom you purchased the product. Upon verification of warranty coverage, the dealer or distributor should implement steps to repair or replace the defective product, which may include returning the product to the manufacturer.

### ***Other Conditions or Limitations***

This Warranty excludes transportation to and from the dealer, distributor, or manufacturer to get warranty service, loss of time, loss of revenues, lodging inconvenience, or other incidental damages. This Warranty excludes the cost of repairing or replacing other property which is damaged because of a defect in the product as well as other consequential damages. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you.

THE IMPLIED WARRANTY OF MERCHANTABILITY, AN UNWRITTEN WARRANTY THAT THE PRODUCT IS FIT FOR ORDINARY USE, IS LIMITED TO THE ONE YEAR DURATION OF THIS WARRANTY. ANY OTHER IMPLIED WARRANTIES FOR OUR PRODUCTS ARE LIMITED TO THE ONE (1) YEAR DURATION OF THIS WARRANTY.

Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

### ***Some Law Rights***

This Warranty gives you specific legal right, and you may also have other rights which vary from state to state.

\*HomeCrest takes great care in the selection and application of materials to give your cabinetry the best possible finish. Paragon's solid hard maple front frames are primed, painted and sealed with a durable catalyzed varnish. Any hardwood, by nature, will expand and contract with changes in temperature and humidity levels. Because of this natural tendency, slight but visible cracks may form at Paragon's front frame joints. Also be aware that over time, any of Paragon's white surfaces may be affected by exposure to sunlight, smoke, household cleaners and other substances, making it difficult to match the color of existing cabinets when replacing components, or installing additional cabinets at a later date. These occurrences are not the result of any defects in materials or workmanship.
